- 1.) We must have your Name, Address, Phone Number, and Email Address
 If you are under 18 we will need your age, and contact information of your legal guardian showing consent for you to enter.

- 3.) You must be a Hamilton County resident
- 4.) Each person can enter up to 3 photos per category

- 6.) To maintain ammature eligibility, you cannot exceed an annual income of \$1,000 for your photography.
- 7.) Entries must be your own photography, you cannot enter a photo for a friend.
- 8.) Entries should not have extensive editing. If it is obvious that your entry has special effects or editing done to it, the entry will be disqualified.
- 9.) Winners must be able to provide the original negatives or digital images upon request.
- 10.) Winners cannot get both first place and second place in the same category.
